#### Class & Product Information:

A "Class" is a grouping of PECO's retail customers. There are four Classes: Residential ("R"), Small Commercial ("SC"), Medium Commercial ("MC"), and Large Commercial and Industrial ("LC&I"). The Load Cap for a Class and an RFP Bidder is set so that the customers of that Class have no more than a 65% exposure to any one Default Supplier at any given time. For each Class, the number of tranches bid by an RFP Bidder cannot exceed the Load Cap.

SC and MC Classes. The available tranches and load caps for this RFP are the same for all RFP Bidders and are presented below:

**R Class.** The load caps for the R Class depend on whether an RFP Bidder is also a current Default Supplier The Load Caps are two-fold. There is a limit on the total number of tranches that can be bid across both products, and there is also a limit on the number of tranches that can be bid on the 29-month product. The Load Cap for an RFP Bidder that is a Default Supplier is the Maximum Load Cap less the number of tranches won in the Spring 2009 solicitation. RFP Bidders that did not have winning Bids in the Spring 2009 solicitation can bid up to the available number of tranches for the R Class.
