

Invitation for Comments: PECO Procurement Data Room

Background

The PECO Energy Company Default Service Program RFPs are to procure full requirements products and energy blocks for PECO's Default Service customers. Full requirements products are procured for each of four classes of customers (Residential, Small Commercial, Medium Commercial, and Large Commercial and Industrial) and for various supply periods.

NERA is the Independent Evaluator for the solicitations under these RFPs. NERA provides information to prospective suppliers through the Web site, <u>www.pecoprocurement.com</u>. The Web site includes a Data Room (<u>www.pecoprocurement.com/index.cfm?s=dataRoom&p=dataroom</u>) that contains historical data series. The Monthly Data page of the Data Room is updated on the 13th of each month. Data items on the Additional Data page are updated occasionally.

Invitation to Submit Comments

Prospective suppliers are invited to provide feedback on the Data Room. The Independent Evaluator invites comments on:

- the organization of the Data Room;
- the existing formats for data series;
- additional data that would be useful for the preparation of bids, along with an explanation of how such additional data is useful to prospective suppliers for bidding in the PECO Default Service Program RFPs.

In requesting additional data, prospective suppliers are asked to consider the fact that due to time, resources, and system constraints, it may not be feasible to provide the additional data or to provide alternative formats that a prospective supplier may request. PECO will give priority to items: a) that have been requested by multiple parties; b) that have been requested early in the comment process; and c) for which an explanation is provided substantiating how the additional data item is useful to prospective suppliers bidding in the PECO Default Service Program RFPs.

All comments and requests will be reviewed by representatives from PECO and the Independent Evaluator. All requests will be carefully considered. Individual responses will be provided for all comments and requests.

Timeline and Process

1. Comments and requests regarding the Data Room must be submitted using the Comment Form available here:

4. Comments must be submitted by <u>July 8, 2009 at 6pm EST</u>. Individual responses will be provided to each prospective supplier by July 22, 2009.
