ACCEPTABLE Modifications to the Pre-Bid Letter of Credit April 2, 2012

The Standard Pre-Bid Letter of Credit is appended as Appendix 11 to the Default Service Program RFP Rules for Block Energy Products. This document contains a comprehensive set of modifications to the Standard Pre-Bid Letter of Credit that are acceptable to PECO. All modifications to the Standard Pre-Bid Letter of Credit accepted for the benefit of a single RFP Bidder are available to all RFP Bidders on an optional basis. All such modifications are posted in this document.

The acceptable modifications listed in this document are deemed acceptable for the Pre-Bid Letter of Credit for the Block Energy RFP.

Upon being notified that the demand for payment was not effected in conformity with this Letter of Credit, you may attempt to correct any such non-conforming demand for payment to the extent that you are entitled to do so, provided, however, in such event a conforming demand for payment must be timely made in accordance with the terms of this Letter of Credit.

Acceptable Modifications to Paragraph 6

6.
